ALCOHOL COMPLIANCE

On August 17th, 2023, the BCDPC, in conjunction with the Illinois State Police, Zone 2 Investigations Rockford, the Boone County Health Department, Belvidere Police Department and the Boone County Sheriff's Department, conducted alcohol compliance checks on 27 on-premise retail businesses. Out of those 27, 12 of the businesses were not compliant and sold to an underage youth. One of the biggest factors when determining if a customer is underage is their ID. Retailers or businesses selling alcohol should always ask for an ID; appearances can be deceiving. Youth under 21 have a distinctly different drivers license than someone that is 21 and older-their ID is vertical, not horizontal. COALITION UPDATES

DARIN LAHOOD MEETING

The BCDPC recently met with United States Congressman Darin LaHood, who currently represents the constituents of the 16th Congressional District of Illinois. Congressman LaHood also serves on the The Ways and Means Committee-the House's oldest committee and has jurisdiction over all taxation and other revenue-raising measures, trade and tariffs, healthcare, and Social Security. Members of the BCDPC met with Congressman LaHood to introduce the coalition and our mission, and educated Congressman LaHood on issues like substance abuse among youth. Congressman LaHood was very interested in hearing about the coalitions past accomplishments, like Drug Disposal bins, compliance checks and the vape ordinance. The coalition also discussed future goals in conjunction with LaHood, particularly concerning sustainability, letters of support, and representing the coalition.

DRUG FREE COMMUNITIES GRANT AWARDED

The BCDPC is proud to announce that they were awarded a competing continuation of the Drug-Free Communities (DFC) Grant! This grant is awarded to local coalitions in hopes of establishing and strengthening collaboration among communities, and thereby reducing substance use in youths. The DFC hopes that by allowing communities to address their specific needs at a local level, various sectors can come together for a common goal: reduce youth substance use. With the DFC Grant, the BCDPC can continue on with improving the quality of life for all in Boone County. The competing continuation of the DFC grant awards the BCDPC \$125,000 annually until 2028. Each additional year requires a larger cost-match in order for the BCDPC to reach full sustainability.











In collaboration with the BCDPC and a Chapter of the Illinois Human Performance Project (ILHPP), the Youth Leadership Council has rebranded as PALS- Prevention, Advocacy, Leadership and Strategies. The ILHPP was created by John Underwood, a performance researcher and Olympic trainer; their program mission centers around promoting healthy choices and developing leadership skills in youth. With this in mind, our focuses have expanded to not only include substance abuse prevention, but nutrition, sleep, mood & mindset, and chemical health.
